

### AMENDED ARTICLES OF INCORPORATION

OF

## HELP & ASSISTANCE FOR ROTARY PHILIPPINE DISTRICTS, INC. FORMERLY: HELP & ASSISTANCE FROM ROTARY INC.

#### KNOW ALL MEN BY THESE PRESENTS:

We, the undersigned incorporators, all of legal age, have this day voluntarily agreed to form a non-stock and non-profit association under the laws of the Republic of the Philippines.

#### THAT WE HEREBY CERTIFY:

Article I: That the name of this association shall be:

## <u>PHILIPPINE DISTRICTS, INC.</u> (AS AMENDED ON 3 JANUARY 2014)

Article II: That the purposes for which this association is formed are:

To gather and organize business, professional and community leaders, especially Rotarians and Rotary Clubs in our society, not for the purpose of earning profit, but for fostering encouraging and engaging in activities aimed at relieving the destitute, helping the disadvantaged and distressed, aiding economically depressed communities, assisting communities with some of their problems and needs, and promoting public interest, humanitarian service and social welfare, such as but not limited to the following: donation and provision of relief, recovery and rehabilitation items and materials, medical assistance, sanitation programs and other health services, feeding and nutrition programs, temporary and permanent shelter, repairs and construction of school buildings and other infrastructures.

Article III: That the association shall have its principal office at:

No./Street UNIT 1903 CITYLAND HERRERATOWER, V.A. RUFINO COR. VALERO STREETS, SALCEDO VILLAGE, MAKATI CITY Article IV: That the term for which said association is to exist is FIFTY (50) years from and after the date of issuance of the certificate of incorporation.

Article VII: That the total contributed capital of the association is TWENTY FIVE THOUSAND PESOS (Php25,000.00) contributed by the incorporators, trustees and members.

Article VIII: That no part of the income which the association may obtain as an incident to its operation shall be distributed as dividends to its members, trustees or officers subject to the provisions of the Corporation Code of the Philippines on dissolution. Any profit obtained by the association as a result of its operation, whenever necessary or proper shall be used for the furtherance of the purposes enumerated in Article II, subject to the provision of Title XI of the Corporation Code of the Philippines.

Article IX: That JOSE Q. CIFRA has been elected by the subscribers as Treasurer of the association to act as such until his successor is duly elected and qualified in accordance with the by-laws; and that as such Treasurer, he has been authorized to receive for and in the name and for the benefit of the association, all contributions and donations to the association.

Article X: That the incorporators and trustees undertake to change the name of the association as herein provided, or as amended thereafter, immediately upon receipt of notice or directive from the Securities and Exchange Commission that another corporation, partnership or person has acquired a prior right to the use of that name or that the name has been declared as misleading, deceptive, confusingly similar to a registered name, or contract to public morals, good custom or public policy.
